

A special meeting of the Bowdle Board of Education was held on March 21, 2022 at 7:30 am at the Bowdle School with the following members present: Mitzel, Zinter, Eisenbeisz, Osterday, and Schlechter.

Others present: Carolynn Nelson and Tara Beitelspacher.

Chairman Mitzel called the meeting to order.

Motion by Osterday and seconded by Zinter to approve the agenda as presented. All voted aye. Motion carried.

Zinter reported a conflict. There were no disclosures and no open forum.

Motion by Eisenbeisz and seconded by Osterday to move \$4500.00 from Capital Outlay to the FBLA Fiduciary Account. All voted aye. Motion carried.

Motion by Osterday and seconded by Schlechter to approve the 2022-2023 Bowdle School District Teacher Negotiated agreement with changes. Zinter abstained. Roll call vote was taken. All voted aye. Motion carried.

Motion by Osterday and seconded by Schlechter to approve the following teacher contracts; Tandy Reilley, Gale Lien, Susan Holsworth, Rebecca Hettick, Ashley Anderson, Mariah Geier, Clay Cheskey, Jeanne Bitz, Jessica Zempel, Shauna Severson, Sarah Rathert, and Megan Zinter. Zinter abstained. Roll call vote was taken. All voted aye. Motion carried. All contracts must be signed and returned by April 8th, 2022.

Reorganization and reassignment transfers were discussed. Due to there being so many moving parts and not enough teachers to fill all positions this was tabled until after meeting with the teachers on March 22 at 3:30 PM.

Motion by Zinter and seconded by Schlechter to recess the meeting until March 31st at 5:30 PM. All voted aye. Motion carried.

The meeting was recessed until March 31st at 5:30 PM.

Chairman Mitzel declared the recess from March 21 over and called the meeting to order.

Motion by Schlechter and seconded by Osterday to approve the agenda as presented. All voted aye. Motion carried.

Mr. Serna gave an overview of reorganization and reassignment transfers. He went over student population numbers and reported that the lunch program will go back to 2019 standards and there will

no longer be free breakfast or lunch. He summarized the new Jr. High program with adding 6th grade and consolidating Pre-K and kindergarten. He then reviewed the nine period day for High School and Jr. High. Some discussion followed.

Motion by Eisenbeisz and seconded by Zinter to enter Executive Session at 6:23 PM to discuss Personnel SDCL 1-25-2 (1) and Student Matter SDCL 1-25-2 (2). All voted aye. Motion carried.

Nelson, Beitelspacher, Rohrbach, and Hartman left the meeting at this time.

Motion by Osterday and seconded by Schlechter to adjourn the meeting. All voted aye. Motion carried.
